INVITATIONS FOR BIDS (IFB)

- 1. Wangdue Phodrang Dzong Reconstruction Project (WDRP) invites sealed bids from the individuals/firms/ contractors for the sale of the un-sized stone. The bidders are requested to inspect the stone dump sites prior to the submission of the bids and the un-sized stones shall be lifted from "as is where is basis".
- Interested bidder can purchase the bidding document from the office of Wangdue Phodrang Dzong Reconstruction Project, during office hour from 17.03.2017 to 17.04.2017 upon payment of Nu.500 (Non-Refundable) in cash. The document can also be downloaded from www.wangduedzong.gov.bt, at free of cost.
- **3.** The bidder(s) shall submit one original of the priced quotation with the Form of Bid and clearly marked **ORIGINAL**. In addition, the bidder(s) should also submit one copy marked as **COPY**. The quotation including all documents in the attached format should be sealed in an envelope as required by PRR 2009 clause 5.1.7.2 and addressed to and delivered at the following address:

- 1. The bid shall be accompanied by a Lump sum bid security of Nu. 20, 000.00 (Twenty Thousand) only in the form of cash warrant, demand draft or unconditional Bank Guarantee having validity of 90 days from the date of opening of the bid. Any bid not accompanied by bid security shall be treated as non-responsive.
- Bids must be delivered to Wangdue Phodrang Dzong Reconstruction Project on or before 1000 hours on 18.04.2017 and will be opened on the same day at 1030 hours, in the presence of the bidders who wish to attend.
- 3. Quotations by fax or by electronic means are **not** acceptable.
- 4. The quotation should be submitted as per the following instructions and in accordance with the attached Contract. The attached Terms and Conditions of sale is an integral part of the Contract.
- 5. The bid shall be valid for a period of 60 days from the deadline for receipt of sealed bid (s).

- 7. The quotation(s) will be opened in the presence of bidders or their representatives who choose to attend at the specified venue and time.

Documents required to be submitted as part of the Quotation

The original and *copy(ies)* of quotation submitted by the prospective buyer shall comprise the following:

- (a) A duly completed and signed priced quotation as per the Schedule of Items and the Priced Quotation.
- (b) The required bid security.

Terms and Conditions.

The Terms and Conditions hereinafter may only be varied with the written agreement of the Purchaser and no terms and conditions put forward at any time by the Supplier shall form any part of the Contract.

- 1. The highest bidder, whose bids are accepted will have to deposit 100% payment for the total quantity of stone required prior to the lifting of the material and failing to deposit the total amount shall result in the cancellation of the contract and the bid security amount will be forfeited.
- 2. The highest bidder whose bid will be accepted by the Project Tender committee will have to take delivery of the material at their own cost within 60 days from the deposit of full payment (in Cash or demand draft drawn in favor of Project Director, Wangdue Phodrang Dzong Reconstruction Project).
- 3. The winning bidders shall bear all taxes, loading and unloading charges, royalties and any other costs involved for the lifting of the material from the site and the Project Management shall not bear any cost.
- 4. The materials shall be lifted only during the office hour from 7.30 am to 5.00 pm (Monday to Saturday) in presence of the Project Officials.
- 5. The bidder whose bid price is lower than the reserved price of Nu.20/cft shall not be considered for evaluation.
- 6. In case of any dispute or problem with regards to the tender, the decision of the Project Tender Committee is final and binding.
