All bids should be accompanied by bid security of Nu. 50, 000.00 only as lump sum in the form of demand draft/ cash warrant/ bank guarantee in favor of the Project Director, WDRP, Wangduephodrang and should be delivered on 05.01.2018 before 1400 hours in accordance with instruction given in the bidding documents and will be publicly opened on the same day at 1430 hours in the Project Conference Hall, WDRP, in the presence of interested bidder's or bidder's representatives.
- 6. The bids/tender documentssubmitted should be of two copies. The original and duplicate copy should be packed in two different envelopes and marked the outer envelope of original documents as "ORIGINAL" and envelope of other as "COPY".
