## INVITATION OF BIDS

### Supply of Stone boulder to Wangduephodrang Dzong Reconstruction Project, Wangduephodrang.

#### Terms of Reference:

1. Wangdue Phodrang Dzong Reconstruction Project (WDRP), Wangdue Phodrang would like to invite sealed bids from the eligible national suppliers having valid Trade License and full filling the following conditions for the supply of Stone boulder to the WDRP, Wangdue Phodrang. The copy of the Trade License should be attached with the bid submission.
  - a. The supplier should have its own stone quarry, **OR**
  - b. Supply from the surface collection area identified by the project (i.e. from Harachu – Rukha Farm Road under Athang Gewog, 13KM from Wangdue Tsirang Highway)
  - c. The supplier should have Access to or Availability of credit Facilities. The amount of line of Credit is Nu.1, 500, 000.00 (One Million Five Hundred Thousand). Please attached a letter of credit issued by Bank.
  - d. The supplier should clearly mention the name of the quarry site. The Project Management shall inspect the quarry for quality and the sustainability of the quarry. The supply work shall be awarded based on the quality and the available quantity at the quarry site. The boulders should be hard and dress able (preferably quartzite).
  - e. The supplier should have 2 Nos. of Tripper Truck and an excavator on their own.
2. The period for the execution of the assignment is valid till 30<sup>th</sup> June 2019.
3. Interested bidders may obtain information for the bid forms or inspect the bidding documents at the office of the Project Engineer(C), WDRP. Further inquiries, please call 02-481549 during office hours.
4. A complete set of bidding documents can be downloaded, free of cost, from the project website [www.wangduedzong.gov.bt](http://www.wangduedzong.gov.bt).
5. All bids should be accompanied by bid security of Nu. 50, 000.00 only as lump sum in the form of demand draft/ cash warrant/ bank guarantee in favor of the Project Director, WDRP, Wangdue Phodrang and should be delivered on 22.08.2018 before 2:00 PM in accordance with instruction given in the bidding documents and will be publicly opened

on the same day at 2:30PM in the Project Conference Hall, WDRP, in the presence of interested bidder's or bidder's representatives.

6. The bids/tender documents submitted should be of two copies. The original and duplicate copy should be packed in two different envelopes and marked the outer envelope of original documents as "ORIGINAL" and envelope of other as "COPY".
7. The bids should be signed and official seal affixed. The bids shall be rejected, if submitted without signature and official seal.
8. The rate should be inclusive of royalty/permits, transportation, loading and unloading charges. The rate must be in specific units as noted in bidding format.
9. The size of the stone required is as follows:
  - a. Minimum size : 16"x10"x3"
10. The materials will be verified and received by the committee only during office hours from 7.30AM to 4:30PM (Monday to Saturday) not during Sunday and government holidays.
11. The successful bidder and his employee shall be bound by the Procurement Rules and Regulation 2009 and should follow all necessary formalities. Any illegal activities, should be the full responsible of the supplier.
12. The bill payment will be purely based on verified measurement done at the receiving site by the committee and voids of 15% shall be deducted.
13. The supply should be completed within the date mentioned in the supply order. If not, the liquidated damage of 0.07% shall be levied, as per the Procurement Rules and Regulations.
14. During the delivery of goods at site, the supplier should handover both original and duplicate copy of documents (Permits/Challans) to the receiving / verifying Engineer or Work Assistant. Duplicate copy of documents, duly signed by the site In-charge will be handed over to the supplier and should be attached with the bill.
15. The materials unloaded without verification or submission of required documents will not be entertained for payment.

16. The successful bidders have to draw the execution agreement deeds with the WDRP office, Wangdue Phodrang on depositing performance bond Nu. 1, 50, 000.00 in the form of valid Bank Guarantee within the 15 days from the receipt of award notification.

17. The decision of the Dzong Reconstruction Committee shall be final and binding.
